The Tennessee Open Meetings Act requires notice of the meeting itself but does not specifically require notice of the content of the meeting. Tenn. Code Ann. § 8-44-103. Accordingly, a governing body is not required to post a meeting agenda as part of the public notice required under the Tennessee Open Meetings Act. *Lewis v. Cleveland Mun.*

§ 143-318.10. All official meetings of public bodies open to the public. (a) Except as provided in G.S. 143-318.11, 143-318.14A, and 143-318.18, each official meeting of a public body shall be open to the public, and any person is entitled to attend such a meeting.
